4.	EGM ERROR	746	A list for the same is being uploaded on the website of Kolkata Customs at: http://kolkatacustoms.gov.in/Airport/ . The EDI Section at ACC will resolve the matter immediately as soon as the errors have been rectified by the Airlines.

IGST/D BK SB pending at PFMS	1234	Exporter/CHA are requested submit a copy IEC, a latest Bank statement having mentioned IFSC Code and a forwarding letter in which Bank Account Details(IFSC, Account No., AD Code and Bank Address) are mentioned. They can forward these detail at the dedicated mail mentioned above also. Further as per Advisory no. 36/2020 dated 24.09.2020 issued through DGS & DM the Exporter can on their own can correct their PFMS detail.
