PUBLIC NOTICE NO.67/2021

Subject: Extortion of money in the name of Customs Officers- regarding.

Instances have come to the notice of this Office that importers/exporters are being cheated by certain unscrupulous elements, who promise to get the Customs clearance done against payment of some amount. They impersonate as Customs officers by using their names and instruct the importers to deposit money in the Bank Accounts created for fraudulent purpose of extorting money. They may also issue fictitious receipts for having received the amount.

2. Members of exim trade are informed that the Customs duty shall be deposited in favour of Commissioner of Customs (Government Account) through the nominated nationalized bank. State Bank of India is the nominated bank for International Air Cargo Complex, Kolkata.

3. Customs officers never call anyone and ask to pay Customs duty or deposit into any account.

4. Further the exim trade members are hereby alerted not to pay any amount in the name of Customs to any person or to any private account. If anybody demands such payments claiming to be an officer of Customs or the consignment is alleged to be detained by Customs at ACC, Kolkata, then the public are advised to contact the Assistant / Deputy Commissioner of Customs (on. duty), ACC, Kolkata on land line no. 033-2511-1098, or, he/they can send e-mail to accadm-n-apkolcus@gov.in for verification.

5. Difficulties faced, if any, may be brought to the notice of the undersigned.
