**Subject:** Withdrawal of 'Detention Notice' dated 26.06.2019 issued to exporter M/s Satyam Creations Pvt. Ltd. (IEC: 0201016460)

Whereas a Detention Notice of even No. dated 26.06.2019 was issued under section 142 (1)(a)(b) of the Customs Act 1962 to M/s Satyam Creations Pvt. Ltd. (IEC: 0201016460) in the matter of recovery of drawback to the tune of Rs.64,627/- (Rupees Sixty Four Thousand Six Hundred Twenty Seven only) for non realisation of export proceeds.
