1. If the original 'Certificate of Origin' documents are not received in time, delivery of consignment on basis of duplicate documents is subject to permission from the proper officer (Assistant/Deputy Commissioner of Customs) and if required, furnishing a Bond/Bank Guarantee, as deemed fit by the proper officer.
2. If original documents containing 'Certificate of Origin' is not received, then delivery of consignment (with duty exemption under 'Country of Origin' notification benefit) on strength of Xerox Copy of 'Certificate of Origin' can be permitted against furnishing of a Bond/Bank Guarantee (amount equal to the duty foregone/exemption claimed under 'Country of Origin' notification benefit), as deemed fit by the proper officer.

Appeal, if any, against this reply may be preferred within the stipulated period before the Appellate Authority and Additional Commissioner of Customs (Airport & Administration), Custom House, 15/1, Strand Road, Kolkata - 700001.
