Respected Sir/Ma'am,

We hereby file this application under the Right to Information Act, 2005 to seek the following information from Kolkata Customs:

- a) Whether the drugs marketed under the name "TOFANIB" or "Tofacitinib"/



product manufactured by **Globe Pharmaceuticals Limited** (hereinafter referred to as "**Tofanib product**"), bearing address "**Plot 3/KA (New) Tejgaon I/A, Dhaka - 1208, Bangladesh**" and also at "**BSCIC Industrial Estate, Begumgonj, Noakhali, Bangladesh**" is being imported into India from Bangladesh?

- b) If the answer to the question (a) is 'Yes':

- i. Please provide the names and addresses of the person/entities/companies/firms, etc. importing the Tofanib product;
- ii. Please provide all the Bill of Entry Nos. for the Tofanib product;
- iii. Please provide the quantities of the Tofanib products being imported;
- iv. Please provide the ports of lading of the Tofanib products;
- v. Please provide since when is the Tofanib product being imported into India;

- vi. Please provide whether the Tofanib product is presently being imported including the date of its last import;
- vii. Please provide any other information and/or documents that you or any other office under the Centre Board of Indirect Taxes and Customs may have in your power and possession as regards the Tofanib product manufactured by Globe Pharmaceuticals, Bangladesh.

To the best of my knowledge all of the above information is within the public domain and does not fall within the restrictions contained in Section 8 and 9 of the RTI Act and requires to be disclosed in the interest of public health and welfare.

In case I am required to pay certain extra fees for the photocopies requested by me, please do inform me and I shall arrange for it at the earliest.

In case the information requested by me does not fall within the purview of your office, I would request you to transfer it to the appropriate public authority as mandated under Section 5 of the Right to Information Act, 2005.


