**Parawise Information pertaining to Kolkata Customs Commissionerate under CBIC as sought for is given below as per the available records:-**

**Para No. (i):-** Names of officers who have joined Kolkata Customs Zone on ICT basis according to which Establishment Order No. 346/2018 has been published is based upon application by the concerned ICT officers. No database is available with the department of the officers who have joined Kolkata Customs Zone on ICT basis for the period 1970 to 2018 (Year- wise).

**Para No. (ii):-** The date of joining of Sh. (Late) Sanjay Kumar, SCP in Kolkata Customs Zone is 04.10.1996. Yes, he had joined on ICT basis.

**Para No. (iii):-** It has not yet been decided as to whether the names of officers who had expired but had joined Kolkata Customs on ICT basis would be included or not.

**Para No. (iv):-** No.

**Para No. (v):-** Corrigendum in this regard is under process.

**Para No. (vi):-** It has been extended to all petitioners and non petitioners working in this Customs House irrespective of their year of joining prior to 26.12.2016. The names of officers has been included with upon application by the officers concerned or based on available record.

**Para No. (vii):-** Clarification from Board is still awaited.

**Para No. (viii):-** Not applicable.

**Para No. (ix):-** Establishment Order No. 346/2018 is only indicative. It has been taken out upon Board's directive under F. No. C-18012/19/2012-Ad II B dated 03.08.2017. Further steps to place them in "Seniority List" would be taken in due course on orders upon appropriate authority.

**Para No. (x):-** The work is still under process.

**Para No. (xi):-** Fixation of seniority in the seniority lists of respective cadres is still awaited till clarification from the Board.
