This refers to your RTI application bearing the subject Registration no. and date.

As requested, the information being sought in the subject application is hereby provided as below-

1. As per ITC-HS Schedule-1 Import policy, import of items **classifiable** under 96031000 are freely importable. This CTH covers finished products and not raw materials. Plant Quarantine department is Participating Government Agency (PGA) of Customs Department. Any consignment requiring NOC from any PGA is automatically routed to that agency through SWIFT (Single Window Interface for Facilitation of Trade). Hence, any consignment requiring NOC from PQ will be automatically routed to them through SWIFT. Normally no manual reference is made for PQ NOC.
2. In Kolkata Sea (INCCU1), the standard procedure as detailed above is adopted for referring or not referring any consignment for PQ NOC in this Port. For bills of entry which are not automatically routed to PQ authorities for NOC purposes, no manual interference is normally made for PQ NOC.
3. The information sought relates to INMUN1 which is outside the jurisdiction of this office. Therefore, the desired information may be obtained from the concerned authorities.

If the applicant is not satisfied with the reply, he may prefer an appeal to the Appellate Authority, ADC, Amrendra Narayan within 30 days from the receipt of this Order under Section 19 of the RTI Act, 2015
