1	CCUKL/R/2019/50081 dated 11.06.2019	It is noted that the Examining Officers (EO) posted in AG Unit and CC Unit are always given sensitive postings at Ports (Postings in CFS and DOCKS) while Examining Officers posted in other sections are not getting the same. In 2016, few EO were posted in AG and CC Unit. Thus they got sensitive posting in 2017. In 2018, the same EO were again posted in AG Unit and CC Unit. This time again they are very much sure and confident about getting Sensitive Postings at CFS and DOCKS. Thus it is aggrieved that a nexus is being observed between these EO and Specific Department of Custom House without your knowledge sir (here- AG Unit and CC Unit.) This situation is not allowing other EO to get exposure in various CFS and DOCKS and thus limiting their knowledge. Thus provide the detailed provisions for getting postings at CFS and DOCKS.	There is no such provision for getting postings at CFS and DOCKS.
