
**Sub: RTI application Registration No. CCUKL/R/2019/50028 dated 15/02/2019 – regarding.**

This refers to your RTI application bearing the subject Registration no. and date wherein you have requested to inform whether product under the HS Code 96031000 will be given clearance by Customs without PQ NOC or not.

In this regard, it is hereby informed that as per ITC-HS Schedule-I, Import policy, import of items **classifiable** under 96031000 are freely importable. This CTH covers finished products and not raw materials. Plant Quarantine Department is Participating Government Agency (PGA) of Customs Department. Any consignment requiring NOC from any PGA is automatically routed to that agency through SWIFT (Single Window Interface for Facilitation of Trade). Hence, any consignment requiring PQ NOC will be automatically routed to them through SWIFT. Normally no manual interference is made for PQ NOC.

The standard procedure as detailed above shall be adopted in this Port for referring or not referring any consignment for PQ NOC.

If the applicant is not satisfied with the reply, he may prefer an appeal to the Appellate Authority, ADC, Shri Amrendra Narayan within 30 days from the receipt of this Order under Section 19 of the RTI Act, 2015
