Please note that for information involving third parties, an additional 10 days period is permitted by the RTI Act, 2005 to furnish reply in addition to the stipulated 30 days period. Reply to the information you have sought are as below-

Information Sought 1: consignment imported under the cover of bill of entry no. 2801634 dated 11.04.2019 filed by you was found to be mis-declared and subsequently adjudicated vide Order-in-Original No. KOL/CUS/ADC/Port/49/19 dated 21.05.2019. Bill of entry no. 2795834 dated 11.04.2019 pertains to third party and thus the information sought cannot be disclosed to you in terms of Section 8(1)(d) of the RTI Act, 2005 read with Section 2(n) of the Act *ibid*.

Information sought 2: destuffing of consignment covered under bill of entry no. 2801634 dated 11.04.2019 allowed by AC-CFS.

Information sought 3: permission for destuffing was granted in written by AC-CFS on the face of the your request letter and duly communicated by Shed Officers to your authorized Customs Broker.

Information sought 4: Bill of entry no. 2795834 dated 11.04.2019 pertains to third party and thus the information sought cannot be disclosed to you in terms of Section 8(1)(d) of the RTI Act, 2005 read with Section 2(n) of the Act *ibid*.

Information sought 5: NOC from PQ are issued by PQ authorities. Thus, the information sought on NOC may be obtained from them. As regards the cited Circular, it is informed that the said Circular is being duly followed.

Information sought 6: Yes. As per the abovementioned Order-in-Original, the bill of entry was assessed to duty on merit. Also, the issue involves bio-hazard risk and thus NOC from PQ is required.

Information sought 7: De-stuffing permission was granted by the AC-CFS

Information sought 8: Bill of entry no. 2795834 dated 11.04.2019 pertains to third party and thus the information sought cannot be disclosed to you in terms of Section 8(1)(d) of the RTI Act, 2005 read with Section 2(n) of the Act *ibid*.

If the applicant is not satisfied with the reply, he may prefer an appeal to the Appellate Authority, ADC, Shri Amrendra Narayan within 30 days from the receipt of this Order under Section 19 of the RTI Act, 2015
