

As you are aware that CFS Gate Module under ICES Version 1.5 has been implemented in Kolkata (Port) w.e.f. 18/03/2018. During the initial phase all the stake holders including Customs had to face complications with regard to newly implemented procedure. However, during the course of time with the co-operation from all the stake holders this Office could bring down the complications to the minimum. In this connection references can be made to Public Notices issued in this regard. Moreover, this Office has recently published Standard Operating Procedure and Troubleshooting on CFS Gate Module which can be downloaded from Kolkata Customs website.


