STANDING ORDER : 11 /2018

Subject: Recall of Bill of Entry.


It has been observed that large number of files are regularly referred to A.D.C/J.C of Customs (Port) to approve application for Re-Calling of RMS facilitated Bill of Entry to Group on the grounds of Provisional Assessments due to SVB investigation, non-submission of Ship Demurrage Certificate and to submit Undertaking/Bond/Bank Guarantee in terms of Notifications. As System is not equipped to accept option of Provisional Assessment, in such cases intervention of Group Appraiser is required. However, such process of Re-Calling of RMS facilitated Bill of Entry requires time taking compliances. Consequently, it delays assessment and makes concerned A.D.C/J.C take on more work load.

In view of the above, all concerned are hereby instructed that in case of R.M.S facilitated Bill of Entry where:-

- (i) Assessment has to be Provisional for reason of S.V.B investigation;
- (ii) Assessment has to be Provisional for reason of non-submission of Demurrage Certificate and
- (iii) Undertaking/Bond/Bank Guarantee has to be submitted in terms of Notifications;

In such cases Bill of Entry has to be Re-Called by the Deputy/Assistant Commissioners of concerned Groups. No application for Re-Calling of RMS facilitated Bill of Entry is to be referred to A.D.C/ J.C of Customs (Port). The Deputy/Assistant Commissioner of Group will record reasons for Re-Call in the System.
