
Chairman enquired about the latest status of the decisions taken in the previous meeting dtd 01.10.18

AO (P&E) replied that Draft Seniority Lists fixing Seniority Positions of officers as per minutes of the meeting dtd 01.10.18 is underway and draft seniority lists in all cadres would be ready for circulation soon.

DECISION:

1. A note for new Chief Commissioner has to be made giving details of all DPCs pending, DPCs requiring Chief Commissioner as Chairman, and status of recast of seniority list.
2. Updated draft seniority lists of PO and TA as per minutes of the meeting dtd 01.10.2018 to be circulated by Monday, 29.10.18, updated draft seniority list of all other cadres should be circulated within 02.11.2018.
3. Regarding Sports Quota Recruitment, reminders may be sent to Railways and GST regarding procedure adopted by them, however, if no reply is obtained within a week, process will follow on the basis of what is available. In this regard, a proper officer should be sent to the Railway Office to get details of the procedure followed by them. Three member Committees for Sports Quota Selections may be made for each sport under recruitment and letters may be written to respective recognized sports bodies for nomination of external selectors giving them clear guidelines available regarding qualifications of the selectors required. The entire process of sports quota recruitment may be completed within Dec 2018-Jan-2019.
4. Regarding Staff Car Driver Ordinary Grade recruitment, a reminder may be given to C.C.O. with a request to explore the possibility of ascertaining from SSC office about early nomination of Drivers in this regard.
5. Regarding Compassionate Appointment, S.I.U. may be freshly given 15 days time in writing to submit fresh economic status report of candidates presently eligible for Compassionate Appointment. The time period may be extended to a maximum of one month.
6. All pending MACPs to be completed by Dec'2018.
