Container Freight Station (CFS) of M/s. Phonex Logistics Private Limited, located at A-1/46/1, Paharpur Road, P.O.+P.S –Rabindranagar, Kolkata – 700 066 was appointed as "Custodian" vide Public Notice No. 70/2016 dated 22.8.2016 under Section 45 of the Customs Act, 1962.

2. The area of M/s. Phonex Logistics Private Limited at above mentioned address was specified as "Customs Area" vide this Office Public Notice No.63/2016 dated 28.7.2016.

3. Now, after considering the request received from M/s. Phonex Logistics Private Limited and reviewing their functions, in exercise of power conferred to me under Section 45(1) of the Customs Act, 1962, I, Manish Chandra, Commissioner of Customs (Port), Custom House, Kolkata, hereby extend the validity of Custodianship of M/s. Phonex Logistics Private Limited, located at A-1/46/1, Paharpur Road, P.O.+P.S –Rabindranagar, Kolkata – 700 066 further for a period of 5(five) years with effect from 23.8.2018 to 22.8.2023.

4. M/s. Phonex Logistics Private Limited shall execute a Bond of Rs.46.00 Crores (Rupees Forty Six Crores) and Bank Guarantee of Rs.4.60 Crores (Rupees Four Crores Sixty Lakh) with the Commissioner of Customs (Port), Custom House, Kolkata for the safety, storage and transshipment of Import/Export cargo at the said CFS. The Bond value shall however, be subject to satisfaction of Commissioner of Customs (Port) or his authorized officer who will periodically review the performance of the Custodian.

5. An insurance coverage of an amount equal to Rs.266.00 Crores (Rupees Two Hundred Sixty Six Crores) has to be provided by M/s. Phonex Logistics Private Limited. The Custodian is responsible for any loss arising on account of fire/theft or other accidents.

6. This appointment of Custodianship shall be reviewed after 5(five) years.
7. All the conditions laid down in Public Notice No.70/2016 dated 22.08.2016 shall be valid till further orders.
8. The renewal of Custodianship of M/s. Phonex Logistics Pvt. Ltd. is being done without prejudice to any pending enquiry/ Show Cause Notice issued and their outcome.
