**Public Notice No. 95/2018**

**Subject : Sea Cargo Manifest and Transhipment Regulations, 2018**

Attention of all MLOs (Main Line Operator), Steamer Agents, Importers, Exporters, Customs Brokers and other stakeholders who are delivering the arrival and departure manifest for vessels under Section 30 and Section 41 of the Customs Act, 1962 respectively, is drawn to CBIC's Notification No. 38/2018- Customs (N.T) dated 11<sup>th</sup> May, 2018 and Notification No.65/2018 – Customs (N.T) dated 30<sup>th</sup> July, 2018 with respect to the subject Regulations.

2. The subject Regulations supersede the following regulations namely Import Manifest (Vessels) Regulations, 1971, Export Manifest (Vessels) Regulations, 1976 and Transportation of Goods (Through Foreign Territory) Regulations, 1965, pertaining to delivering manifests for sea cargo vessels.

3. Hence, any authorised person who is required to deliver arrival manifest or departure manifest shall apply to the jurisdictional Commissioner of Customs for registration in the Form – I under Regulation- 3 (1) of the Sea Cargo Manifest and Transhipment Regulations, 2018 and shall comply with the other provisions of the said Regulations. For details, stake holders are requested to visit the CBIC website ([www.cbic.gov.in](http://www.cbic.gov.in)).

4. The Sea Cargo Manifest and Transhipment Regulations, 2018 will come into force with effect from 1<sup>st</sup> November, 2018.


