Transhipment Regulations, 2018

Attention of all MLOs (Main Line Operator), Steamer Agents, Importers, Exporters, Customs Brokers and other stakeholders is invited to this Office Public Notice No. 95/218 dated 23<sup>rd</sup> October, 2018 wherein it was said that "The Sea Cargo Manifest and Transhipment Regulations, 2018" shall come into effect from 1st November, 2018 in terms of the amendment of the said Regulations vide CBIC Notification No. 65/2018-Customs (N.T) dated 30.07.2018.

2. In this connection, it is brought to notice that in terms of CBIC Notification No. 88/2018-Customs (N.T.) dated 30.10.2018, CBIC has made further amendment to the "The Sea Cargo Manifest and Transhipment Regulations, 2018" to the effect that the said Regulations shall come into force on 1st March, 2019.
