**Public Notice No. 103 /2018**

Container Freight Station (CFS) of M/s. Century Plyboards (India) Limited (Sonai CFS), located at Block –B & C Sonai, Khidderpore, Kolkata – 700 088 ,was appointed as "Custodian" vide Public Notice No. 59/2008 dated 05.11.2008 under Section 45 of the Customs Act, 1962.

2. The area of M/s. Century Plyboards (India) Limited, Sonai CFS at the above mentioned address was specified as "Customs Area" vide this Office Public Notice No.56/2008 dated 17.10.2008 under Section 8 of the Customs Act, 1962.

3. Now, after considering the request received from M/s. Century Plyboards (India) Limited, Sonai CFS and reviewing their functions, in exercise of power conferred to me under Section 45(1) of the Customs Act, 1962, I , Manish Chandra, Commissioner of Customs (Port), Custom House, Kolkata, hereby extend the validity of Custodianship of M/s. Century Plyboards (India) Limited ( Sonai CFS), located at Block –B & C Sonai, Kolkata – 700 088 further for a period of 5(five) years with effect from 04.11.2018.

4. M/s. Century Plyboards (India) Limited shall execute a Bond of Rs.33.56 Crores (Rupees Thirty Three Crores and Fifty Six Lakhs) and Bank Guarantee of Rs.3.35 Crores (Rupees Three Crores and Thirty Five Lakhs) with the Commissioner of Customs (Port), Custom House, Kolkata for the safety, storage and transhipment of Import/Export cargo at the said CFS. The Bond value shall however, be subject to satisfaction of Commissioner of Customs (Port) or his authorized officer who will periodically review the performance of the Custodian.

5. An insurance coverage of an amount equal to Rs.90.26 Crores (Rupees Ninety Crores Twenty Six Lakhs only) has to be submitted by M/s. Century Plyboards (India) Limited. The Insurance amount, shall however, be subject to satisfaction of Commissioner of Customs (Port) or his authorized officer who will periodically review the same. The Custodian is responsible for any loss arising on account of fire/theft or other accidents.

6. They have to undertake to indemnify the Commissioner of Customs from any liability arising on account of damages caused or loss suffered on imported or export goods, due to accident, damage, deterioration, destruction or any other unnatural cause during their receipt, storage, delivery, dispatch or otherwise handling under Regulation 5(6) of Handling of Cargo in Customs Areas Regulations, 2009.

7. This appointment of Custodianship shall be reviewed after 5(five) years. The duration of the appointment of M/s. Century Plyboards (India) Limited (Sonai CFS) as 'Custodian' and as "Customs Cargo Service Provider" shall remain valid for five (5) years unless otherwise suspended/revoked/cancelled prior to the expiry of the said period. The Commissioner of Customs (Port) shall have the right to review the approval as 'Customs Cargo Service Provider' before the completion of five years for failure to comply with the provisions of the Customs Act, 1962 and/or of "Handling of Cargo in Customs Areas Regulations, 2009", as amended or failure to pay any confirmed demand for Cost Recovery Charges, outstanding, if any.

8. The Custodian M/s. Century Plyboards (India) Limited (Sonai CFS), approved as Customs cargo Service Provider shall abide by all the provisions of the Customs Act, 1962 and "Handling of Cargo in Customs Areas Regulations, 2009", as amended and other Regulations, Notifications and applicable Orders. All the conditions laid down in Public Notice No.59/2008 dated 5.11.2008 shall be valid till further orders.
