Sub: Procedure for movement of containerized import cargo form Port Terminal to different Container Freight Stations (CFSs) under Kolkata (Port) - Implementation of CFS and Gate Module under ICES Version 1.5.

Attention of all Steamer Agents/Shipping Lines, Main Line Operators (MLO), Importers, Customs Brokers, CFS operators, Kolkata Port Trust and Stake Holders is drawn to Public Notice No. 07/2018 dated 23/01/2018 on the subject matter.

It has come to the notice that the required formalities like registrations of "TR" bonds by CFSs and registration of one time Authorizations given by CFSs to individual MLO's are yet be completed. "

Therefore, it is intimated to all that the implementation of the CFS Gate Module which had been scheduled for 15/02/2018 shall now be postponed to 01/03/2018. It is further intimated that at present there is no option to generate Gate Pass at the time of movement of trucks from Terminal to CFSs. As such the earlier procedure of Form-II will be retained wherein Preventive Officer(s) shall continue to endorse the Truck No., Container No., Seal No., Gate Pass No. date and time in the Form-II till the issue is resolved in consultation with Port
