
Terms & Conditions

1. The sealed Tender along with Bid security of 2 % of the bid submitted shall submit his bid in two parts viz. 'Technical bid' and 'Financial Bid' in separate sealed covers super scribed with the words ' Technical Bid 'and ' Financial Bid ' as the case may be. The Demand Draft/Pay order for earnest money should be submitted in a separate sealed envelope and super scribed with words "Earnest Money". The two parts of the bid and the envelope containing EMD shall be placed in one sealed cover which shall be marked and super scribed "tender for REPAIRING OF CAT IIIB- 19 & 20". The Tenders registered with the Central Purchase Organization and/or national Small Scale Industries Corporation is exempted from bid Security.
2. The successful bidder has to submit 5% of the bid amount as Performance security which will remain with the department for a period of 60 days beyond the date of completion of all the contractual obligations of the supplier including warranty and after that would be refunded to the supplier
3. The bid should be submitted only after thorough inspection of the vessel.
4. Financial bid of only those suppliers will be considered who are found eligible in their Technical bid.
5. Item-wise break-up of the Bid amount must be provided.
6. The price quoted should be inclusive of all taxes & other charges.
7. Parties must mention their Sales Tax/Vat Regn. No. in their quotations.
8. Parties must mention the brand name and quality of the products in their quotations to be used.
9. Parties should inspect the nature of work before submitting the quotations and the nature of work may be detailed in their quotation. For inspection, query or clarification they may approach Superintendent of Customs (P), for Marine, Custom House, Kolkata.
10. Parties should provide warranty of at least six months for the above-mentioned job.

11. The sealed quotations should be submitted in the tender Box kept in the SCH Unit, Ground Floor, Custom House, 15/1, Strand Road, Kolkata-700 001, before 03:30 P.M., within 15 working days from the date of this notice.
12. The department reserves the right to reject/cancel the Tender without assigning any reason thereof.
