PUBLIC NOTICE NO. 49/09 Dated... 01.10.09


It is notified for information of the Importers, Exporters, Steamer agents, MLOs, C.H. Clearing Agents and all other concerned that the container freight station (i.e. CFS) of M/S. A.L. LOGISTICS PVT. LTD., Haldia was declared as a 'Customs area' vide this Custom House Public Notice No. 84/03 dated 10.11.2003 . M/s. A.L. Logistics Pvt. Ltd. was appointed custodian vide Public Notice No. 85/03 dated 10.11.03. They were permitted to handle /transport/store the containerized import and export cargo from Haldia Dock Complex to their CFS and vice versa. Accordingly, M/s. A.L. Logistics Pvt. Ltd. , Haldia are carrying business as per the norms, conditions and procedures laid down in the Public Notice No. 86/03 dated 10.11.03 .

2. Considering the request of trade and problems faced by the KOPT to bring the full load of containerized vessels into Kolkata port due to draught problem, M/s. A.L. Logistics Pvt. Ltd. , NH 41 , Vill & P.O. Debhog , P.S. Bhowanipur , Sub Division , Dist. East Midnapur , Haldia , West Bengal were also permitted to transfer/shifting of import and export containers (FCL only) A/C Haldia from Kolkata port to their CFS at Haldia and vice versa vide Public Notice No. 64/07 dated 20.11.07. The said permission was granted upto 31.3.08 and was extended to 30.09.08 vide P.N.No. 28/08 dated 25.04.08 and was also extended upto 30.09.09 vide P.N.No. 58/08 dated 17.10.08.

3. Now considering their request and reviewing their antecedents M/S. A.L. LOGISTICS PVT. LTD. NH 41, Vill & P.O. Bhowanipur , sub Division , Dist. East Midnapur, Haldia , West Bengal is hereby permitted further to transfer/shifting of import and export containers (FCL only) A/C Haldia from Kolkata port to their CFS at Haldia and vice versa for the period w.e.f. 01.10.09 to 30.09.2010. All the conditions and procedures to be followed according to Public Notice No. 64/07 dated 20.11.2007.
